Description

The CGM-505 is an environmental, industrial and commercial indoor carbon monoxide gas detector specially designed to interlock with building management systems or other devices monitoring fossil fuel appliances.

The CGM-505 is designed to detect unsafe levels of carbon monoxide in the mechanical room or monitoring room.

The onboard dry contacts are programmed to energize upon start-up and will de-energize if unsafe levels of CO are present.

Relay #1 is preprogrammed to close a dry contact if the carbon monoxide level reached 50 ppm for five minutes, and relay #2 will close a dry contact at 100 ppm instantaneously.

An audible alarm activates at 50 ppm.


